The above courses will be opened in the college subject to the following conditions: -

- (a) The Principal, Niranjan Government Women's College, Aska, Ganjam is allowed to open the above self-financing courses with from the academic year 2023-24 in collaboration with **Master Educational and Charitable Trust**, Ramachandrapur, Ganjam, Odisha by signing MoU with stipulations.
 - i. The UGC Guidelines for starting New Courses in Autonomous Colleges shall be followed strictly.

- ii. The college will provide space for running the courses but the entire investment for running the courses shall be made by the collaborator.
- iii. The revenue sharing shall be at the ratio of 30:70 between the College and collaborator respectively.
- (b) The resource persons should be selected through a Selection Committee consisting of the Principal, Representatives of **Master Educational and Charitable Trust**, Ramachandrapur, Ganjam, and such other experts to be selected by college authority as well as Master Educational and Charitable Trust.
- (c) The Government will not provide any funds and staff for running the above courses.
- (d) As per UGC guidelines for Colleges, Berhampur University, Berhampur shall be duly informed of the opening of such Courses and necessary affiliation may be obtained from the University from the year 2023-24.
- (e) The Principal of the college should be extremely careful for;
 - i. Proper preparation of courses of studies;
 - ii. Proper selection of students:
 - iii. Proper conduct of classes:
 - iv. Quality teaching; and
 - v. Maintenance of discipline;
- (f) Besides, the amount due to be paid to the Service Provider should be released in installments after a proper assessment of their performance.
- (g) The principal shall ensure that running the self-financing courses in no way affects the general teaching of the College.
